

Section 5: EXHIBITIONS, CARNIVALS and RODEOS

5.1 License Required

It shall be unlawful to conduct or operate within the City any exhibitions, carnivals or rodeos which are open to the public without first securing a business license and obtaining a Temporary Use Permit when applicable.

(1) The term "exhibitions" as used in this section shall be held to mean and include circuses, menageries, carnivals, sideshows, and other similar arrangement enterprises, which are open to the public and for admission to which a fee is charged.

(2) The term "carnival" as used herein shall mean and include amusement activities (such as corn mazes, pumpkin patches, haunted houses or trails, etc.), rides, merry-go-rounds, booths for the conduct of games of skill, food dispensing facilities, and side shows. A carnival shall not include gambling devices, games of chance, lotteries, punch-boards, or other activities in violation of City ordinances.

(3) The term "rodeo" as used in this section shall be held to mean an exhibition or contest in which people show their skill at mutton busting, riding broncos, roping calves, wrestling steers, etc.

5.2 Conditions

In addition to other requirements set forth herein the applicant shall furnish suitable evidence of his or her intention and ability to comply with the following conditions:

(1)The operator and sponsor of the exhibition, carnival, or rodeo shall each be wholly responsible for maintaining order, and for keeping the site clean, free of trash, papers and other debris. Trash containers in adequate number shall be placed in convenient locations for the use of the public.

(2)No ride shall be placed in operation for public use until the same has been inspected for mechanical, structural, electrical, and other hazards, by a city designated inspector and such other officers or employees of the city having jurisdiction. Adequate safeguards shall be placed to protect both operators and the general public from inadvertently coming in contact with moving parts, belts, motor gears, electrical switches, and other possible or potential hazards.

(3)All rodeos shall provide law enforcement and first responder personnel at all times during the event.

(4)All participants in a rodeo shall provide a Letter of Indemnification stating Bear River Town Corporation aka Bear River City, its officers, officials, employees, and volunteers harmless in relation to any damages or injury that may arise out of participation in the event.

5.3 Certificates of Insurance Required

No license shall be issued for conducting an exhibition, carnival or rodeo on city owned property, until the applicant therefore has placed on file with the City Clerk a certificate or certificates of insurance with Bear River Town Corporation listed as an additional insured, indicating that there is in effect public liability of insurance covering any damages arising out of the use and operation of any and all devices and facilities operated in connection with such exhibition, carnival, or rodeo. Such insurance for exhibitions or carnivals shall be a minimum amount of \$1,000,000 (one million) coverage or the recommended by the city insurance carrier according to risk involved. All rodeos shall provide a minimum of \$2,000,000 (two million) coverage or an amount recommended by the city insurance carrier according to risk involved.
